**NO Flea Market or Yard Sale items please!**

Vendors must be set-up by 9am and remain set-up until 3pm. Vendors agree to stay until 3pm. Any vendors arriving after 9am will not be allowed to set-up and no refunds will be given. Spaces are limited and processed with complete application and payment in full.

Vendors are accepted upon receipt of payment on a first come and first served basis. Rules are as follows:

1. Every effort is made to provide space requested; however, we reserve the right to adjust spaces to the best advantage of the vendors and flow of the festival.
2. Clarksville Chamber members and Harvest Days Festival sponsors will be given primary consideration.
3. Deadline for submission at regular price is September 19<sup>th</sup> and a late fee of \$10 is applied after that date (per space).
4. Applications received by September 19<sup>th</sup> deadline will be notified of space number by email on September 26<sup>th</sup>.
5. **Vendors displays will be in the parallel parking spaces along Virginia Avenue – set-up is facing the sidewalk, stores and buildings.**
6. Vendors must supply their own tents and tables.
7. Electricity or water are NOT provided.
8. Vendors are responsible for picking up and removing all trash and other surplus/debris from their area. Everything must be cleaned up completely.
9. This is a rain or shine fundraising event – please make considerations for that since no refunds will be given for any reason.
10. Spaces are 10X10 (food trucks are an exception).
11. The event is located in parking areas on Virginia Avenue.
