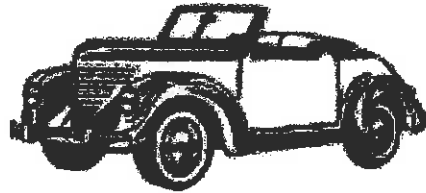


# 23RD ANNUAL ANTIQUE AUTOMOBILE SHOW
