RULES AND REGULATIONS: (THESE ARE PER SPACE)

- ⇒ Spaces are **10 x 10** feet wide - *YARD SALE ITEMS-\$30, NON-PROFITS-\$30,
 - ⇒ COMMERCIAL-\$70 & CRAFT-\$50, FOOD-\$90 for 10x10 \$150 for 10x20
 - ⇒ (Clarksville Chamber Members- **\$25 for retail or craft, Food is \$50 (10x10) \$95 for (10x20)**
 - ⇒ **Applications/registrations received without payment will be held as "pending" for 15 days, after 15 days without payment your application will be denied.** This could affect your inclusion into festival if payment is not received at time of application. First come, first paid basis.
 - ⇒ If paying Credit card there is a fee you will need to add, if not added you will be billed for remaining amount
 - ⇒ Registration deadline is May 5th . **No refunds after April 20.** Any application after **May 1st must be paid in full at time of registration to be considered.**
 - ⇒ **Spaces will be located in the parking spaces along Virginia Avenue FACING THE SIDEWALK. WE DO NOT CLOSE THE STREET FOR THIS EVENT!!**
 - ⇒ Tent spaces available for free-standing, non-staked tents.
 - ⇒ Vendors supply tables and electricity.
 - ⇒ **Set up must be completed by 8 am. Vendor vehicles must be moved** to a side street for parking after downloading your equipment & merchandise.
 - ⇒ Registrations will be processed and confirmation of your spaces will be provided **after** the registration deadline.
 - ⇒ Food vendors will be limited in number, so be sure to request adequate spaces to accommodate your rig or set-up.
- Food Vendors must submit application to VDH to attend the Festival**
- * If applying for yard sale, must be yard sale items. No retail or craft items**
