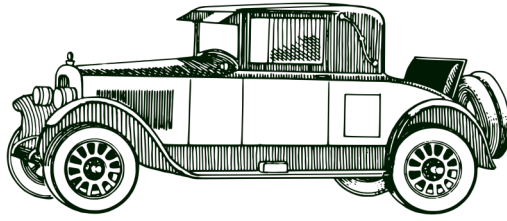


# Twenty-Ninth Annual Classic
